Rental Criteria



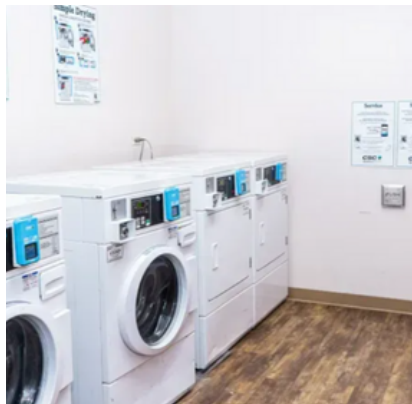
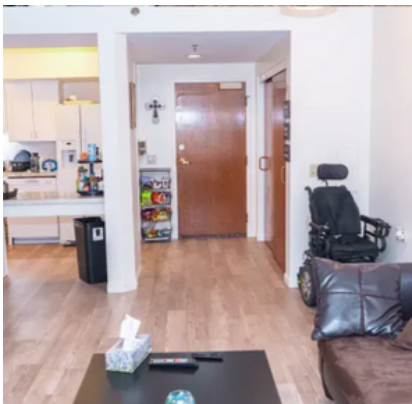
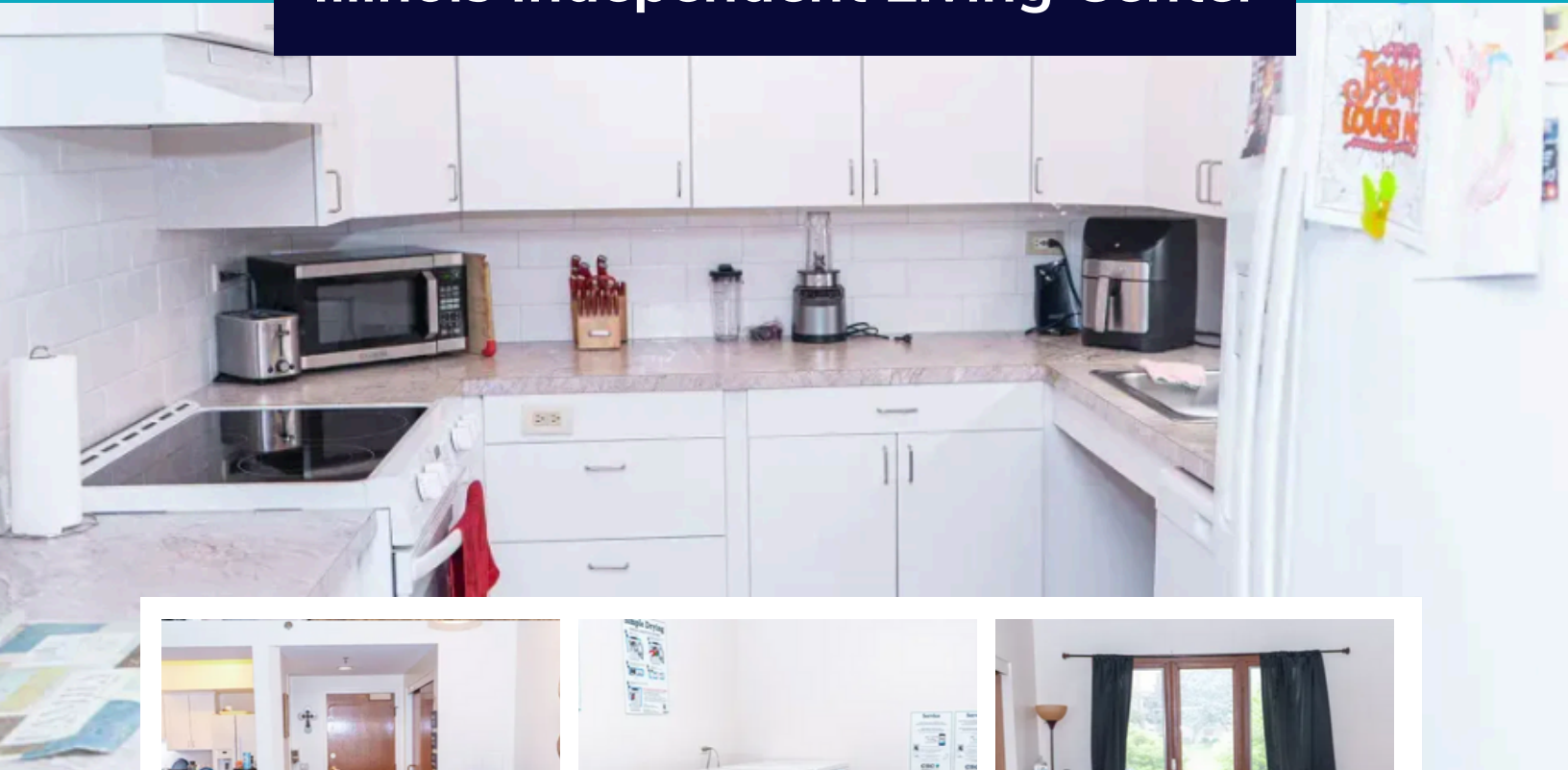
- Physically disabled with mobility impairment
- Able to stand and pivot or able to independently transfer self
- Must be receiving DHS-Division of Rehabilitation Services homemaker services hours
- Able to direct activities of daily living needs per DRS case plan
- Able to live independently with assistance from IILC caregiver
- Able to maintain and care for apartment with some assistance from caregiver
- Must be low to moderate income and able to independently afford rent or have a Section 8 voucher

IILC promotes an independent lifestyle through its wheelchair-accessible architectural design, in-house homemaker services, and convenient access to the community and its opportunities.

IILC is specifically designed for individuals with physical disabilities who are mentally alert, able to live independently, and capable of directing their own care. The building is designed to create a barrier-free and fully accessible living space for residents in an aesthetically pleasing environment. Each unit includes a fully equipped kitchen with full-sized appliances.

Most residents prepare their own meals, do their laundry, and manage other household chores, though they can also direct these activities. Residents can utilize the in-house homemaker program for assistance with their non-medical activities of daily living needs.

Available Services

The Homemaker Program, administered by the Illinois Independent Living Center for clients of the Illinois Department of Human Services – Division of Rehabilitation Services, provides non-medical activities of daily living. All services are self-directed by the resident and include daily tasks such as assisting with showers, dressing, cleaning, meal preparation, laundry, shopping, etc.

The IILC provides specific care support designated in a resident's DHS - DRS case plan. To learn more about qualifying for these services, visit the state's website.



Rental Criteria

Our affordable housing and support services for the mobility challenged include those who are:

- Able to live independently
- At a low to moderate income level
- Receiving DRS Home Service Hours
- Able to stand and pivot/transfer themselves
- Able to direct activities of daily living to assigned caregivers
- Able to pay rent; housing vouchers accepted
